A NATIONAL DEMOGRAPHIC DEVELOPMENTAL HIGHWAY TO HUMAN HARMONY

The salvation of Mankind lies in making everything the concern of all (Solzhenitsyn Nobel Lecture, 1970). I may add that global well0being shall be the obligatory commitment of humanity all over the earth. We are one. The plant wide communities have a lofty socio-economic nexus and moral-material linkage which make the whole world kin. This felicitous fellowship, with its spiritual and temporal confluence, promotes a happy fraternity through planned population policy and compassionate economy. This process leads to a cosmic society free from chaotic overpopulation. This is the consummation of a felicitous world order.

An over-populated world is an under-nourished earth of militant Powers scrambling the rob each other's resources by belligerent processes primarily aimed at imperial domination over colonial subject nations. In pretentiously moral vindication of barbarian competition the Big Powers speciously invoke the opium of religion and intoxication of royal dominion. Indeed, even recently, in the Afghan invasion by over-bearing President Bush, he told the world that during his Sunday prayers his sanguinary God authorized him to wipe out Afghan Muslim terrorists. honest God is the noblest work of Man'. He is never bloodthirsty and ever flies a banner of peace. Malignant man, turned demon, drags God into blood-thirsty inhumanity and injects godist hatred to infuriate bigotry into barbarity. Imperial struggle for resources and means of survival is mainly motivated by rivalry for occupation. Population escalation is at the riot of this violent competition. These national and international factors are manifestations of demographic density beyond the gross wealth and the people, and when there is desperate disparity discontent and discord erupt. Then arsenal the difficulties of family welfare and issues of too many children to be taken care of. Population control thus emerges is a national issue. Under ideal circumstances a child is a boon but the harsh to milieu of backward societies makes pregnancy, delivery, bringing up a baby with nourishment and on good health a big burden. Education even at primary level, becomes a liability with privatization and profit-making as a business making the family budget a terrible problem. Inevitably, birth population regulation claim State control and attention. Child-delivery, slaving and starving to breast-feed and baby-sit the crying little one. And the masculine sex claims nocturnal pleasure, without birth-control contraceptive contravenes and sanity violates gender justice and tortures our sisters by maximizing the privations of

Young girls carrying their own little babies crying to catch the breast of the famished mother is an ungodly sight but religion, in its rabidly communal obscurantism commands kids to come, infant and maternity, mortality notwithstanding! It is a pity that every major religion has a population-crazy God as its power in a democracy, a communal divinity which is an antithesis of secularism and the foundation of a mad brand of militant ballot challenge. Be you bishop, mullah, or baba acharya, if you are bribing the bigots of each faith with malignant communalism and divisive discord, burying the sublime spirituality of Jesus, suppressing the world the

factors. It is pro-poor because too many children is a grave liability they cannot bear. Infant mortality and maternity mortality afflict women. It is feudal reactionarism to oppose family planning. As the Bible put it: Render therefore unto Caesar the things which are Caesars; and unto God the things that are God's. (Oxford Quotation P-67: 20) Rightly, India's national population policy has dialectically formulated a two-child family norm. This is fulfillment of the constitutional fundamental of Justice Social, Economic and Political.

This has nothing to do with religion, Church, mosque or temple but has everything to do with a happy material life organized by State Plan. To oppose population control is to oppose decency and dignity of the vast people in poverty whose aspiration for a better life is a expectation socialist legitimate from a democracy. Humanism must governed legalism and population pluralism must submit to economic wisdom and non-communal nationalism.
